To ensure proper representation of colleges through their elected student representatives to the USC for the Academic Year 2021-2022, and to accommodate the requests of various College Student Electoral Boards (CSEB) for special elections, this call is hereby issued for the special elections of College Representatives to the USC and College Student Council officers for colleges and academic units that have not successfully elected representatives to these positions in the recently concluded UPD Student Council Elections 2021.

The conduct of the special remote student elections shall still be covered by the 2021 Special Guidelines on Remote Student Elections, an addendum to the 2010 Revised University of the Philippines Diliman Student Election Code.

Concerned colleges and their students are requested to note the following dates in relation to the conduct of the Special Remote Student Elections:

7 July, 6PM	Release of first official list of candidates;

9 July, 12 NN	Last day of filing protests on candidates
9 July	Release of final official list of candidates
12 – 18 July	Campaign Period
18 July, 11:59 PM	End of Campaign Period
19 – 23 July, 8AM to 5PM	Special Elections on College Representatives to the USC
23 July, 5PM onwards	Canvassing of votes
23 July, SPM oliwalus	Proclamation of Winners
26 July	Official announcement/transmittal of special election results and
20 July	proclamation of winners to Chancellor
9 August	Affirmation and Turnover Ceremonies

For the special elections, candidates/political parties vying for the position of College Representative to the USC are advised to secure on their own the certifications for their Academic Eligibility and Conduct Eligibility as required in USEB Form 1 (available at bit.ly/HalalanUPD21forms).
